Affiliates	Companies related by common ownership or control. They can be financial and nonfinancial	
	companies.	
	For example, our affiliates include companies with an Allianz name and financial companies such as Allianz Life Insurance Company of North America.	
Nonaffiliates	Companies not related by common ownership or control. They can be financial and nonfinancial	
	companies. Allianz does not share with nonaffiliates so they can market to you.	
Joint marketing	A formal agreement between nonaffiliated financial companies that together market financial	
	products or services to you. Our joint marketing partners include insurance agents and agencies,	
	field marketing organizations, registered investment advisors, broker-dealers, and other financial	
	services organizations.
